

Fort Monroe Authority Board of Trustees August 20, 2015 – 1:00pm Meeting Minutes

The Fort Monroe Authority (FMA) Board of Trustees meeting was held on August 20, 2015 at 1:00pm at the Fort Monroe Post Theatre in Fort Monroe, Virginia.

Call to Order

1. Opening Comments – Ralph Northam, Vice-Chairman

Vice-Chairman Northam called the meeting to order at 1:00pm.

Vice-Chairman Northam welcomed Destry Jarvis to the FMA Board.

2. Roll Call – Jesica Turner, Assistant Secretary

3. Approval of Minutes from June 18, 2015 – Ralph Northam, Vice-Chairman

Reports and Briefings

4. Nominating Committee Report – Colin Campbell, Committee Chairman

Mr. Campbell stated the Nominating Committee recommends the following slate of officers.

Chairman: Jim Moran

Vice-Chairman: Ralph Northam Secretary/Treasurer: John Hutcheson Assistant Secretary: Jesica Turner **MOTION:** I move the approval of the nominated slate of officers as presented.

5. Executive Director's Report – Glenn Oder, Executive Director

Executive Director Glenn Oder reviewed the Executive Director's Report included in the Board package (APPENDIX II). Director Oder reported that the FMA has now moved its headquarters into Building 83. The lease has been signed for the Oozlefinch Brewery. Director Oder reported that attendance is increasing at the Music by the Bay Summer Concert Series. Director Oder stated that Waterfront Park has now identified opportunities for connections to the Inner Fort and potential visitor centers and services.

Director Oder stated that the Foundation is finishing up its sponsorship receptions for the summer. At their reception, the Bodacious Bazaar announced it would make the Fort Monroe Foundation the sole beneficiary of its philanthropic donations.

Director Oder reported that Joe DosReis, Director of Real Estate, has taken a job with a company in North Carolina and will be leaving the Fort Monroe Authority in the coming weeks. Director Oder also stated that he will be submitting his annual evaluation to the Chairman in the coming months.

6. Financial Report – John Hutcheson, Deputy Executive Director

Deputy Executive Director John Hutcheson reviewed the Financial Report included in the Board package (APPENDIX III). As of June 30, 2015, the Authority government fund had \$3,666,837 in cash on deposit in public fund accounts at Old Point National Bank (OPNB). As of the same date, the Authority had \$5,754,998 in other current assets compared to \$3,259,753 in the prior year. The government fund net position as of June 30, 2015 was \$10,739,052 compared to \$7,586,235 as of June 30, 2014.

As of June 30, 2015 the Authority enterprise fund had \$233,629 in cash on deposit as well as \$265,990 in restricted security deposits in public fund accounts at OPNB and \$500 in petty cash. As of June 30, 2015, the Enterprise Fund had \$6,708,146 in current liabilities compared to \$4,040,831 on June 30, 2014.

The Department of Planning and Budget has called for initial requests for the biennial FY17/18 budget by August 31st. The Authority staff will be working to provide any requested changes to the Authority's existing base budget.

7. Chairman's Report – Jim Moran, Chairman

Chairman Moran reviewed the Committee Assignments included in the Board package (APPENDIX IV).

8. Fort Monroe National Monument Report – Kirsten Talken-Spaulding, Superintendent

Superintendent Talken-Spaulding reported that the NPS has provided over \$45,000 in support to the FMA through interstate signage and support to the Casemate Museum. Included in the FMA Board package is the NPS Foundation Document and Overview (APPENDIX V).

9. City of Hampton Report – Bruce Sturk, Director of Federal Facilities

Mr. Sturk reported that the City and FMA staffs are continuing to meet to discuss zoning at Fort Monroe and anticipates a late-2015 or early-2016 implementation timeline. Additionally, the Veterans Administration Hospital has renewed its agreement with the Hampton Community Center at Fort Monroe to use the pool for their patients.

Old Business

10. Status of the Army Transfer to FMA – Glenn Oder, Executive Director

Director Oder stated that negotiations between the Army and the Governor's Administration are ongoing. Director Oder also reported that the FMA has completed the draft of the EDC submission and will be submitting it to the Army in draft form.

Chairman Moran reported that he has had discussions with the Secretary of the Army regarding the property transfer.

11. Transfer of Property from FMA to NPS – Glenn Oder, Executive Director

Director Oder reported that the two Deeds for the transfer of Commonwealth property to the NPS are both substantially complete and the Easement language is very close to being complete. Director Oder also stated that the Cooperative Management Agreement (CMA) and the Task Agreements are moving along smoothly as well and should be completed very soon.

12. Master Plan Implementation

Chip Dicks with FutureLaw reported that he expects to complete the zoning process by the end of 2015 or early 2016.

Mr. Hutcheson reported that the FMA is working on a utility master plan and hopes to present the plan to the Board at the October meeting. Mr. Hutcheson also stated that Dominion made an offer to the Army to resolve the Dominion dispute and is awaiting a response from the officer.

13. Unresolved Property Transfer Issues

Director Oder stated that there is no update on any plans for expansion at the Chamberlin or transfer of the Chamberlin property to the FMA. Director Oder also reported that the FMA staff has received a copy of the Marina lease, thanks to some additional help from Secretary Ward, and has begun to evaluate the lease.

14. Economic Impact Study – Glenn Oder, Executive Director

Director Oder reported that CNU's Center for Public History has been collecting surveys from visitors to Fort Monroe throughout the summer.

15. 2019 Commemoration Activities – Glenn Oder, Executive Director

Director Oder stated that the FMA hosted a meeting for the Hampton 2019 Commission on site at Fort Monroe. In addition, Director Oder will be attending a meeting of the Jamestown-Yorktown Foundation's 2019 Commission later in August. This Commission has recently hired a new Executive Director.

New Business

16. HOPE Crew Program – Destry Jarvis

Mr. Jarvis reported that the National Trust for Historic Preservation has established the HOPE Crew program to conduct preservation projects while simultaneously training young people on preservation skills. Mr. Jarvis stated this program could be utilized at Fort Monroe by both the FMA and the NPS. Mr. Jarvis indicated he would work with Director Oder on moving this idea forward.
