Minutes from February 11, 2021 Meeting

Mr. Joseph called for a motion to approve the minutes of the February 11, 2021 meeting.

Reports and Briefings

4. Financial Report – John Hutcheson, Deputy Executive Director

Deputy Executive Director John Hutcheson reviewed the Financial Report included in the Committee package (APPENDIX II). Mr. Hutcheson reported that the Governor's budget is complete and thanked Senator Locke and Delegate Mugler for their work on the budget. Mr. Hutcheson gave an update on the homeless support services agreements.

There was a question regarding adjusting rents. Mr. Hutcheson reported that the process to increase rents annually was halted during the pandemic and will get back to increasing rents on an annual occurrence.

5. Executive Director's Report – Glenn Oder

Director Oder reported that significant progress has been made on the real estate adaptive redevelopment projects and will be discussed in closed session. The strategic action plan is coming to a close and will be a big topic at the Board of Trustees meeting. The Annual Board of Trustees Retreat will be next week and will not be the normal two-day Retreat.

Old Business

6. Army Transfer – John Hutcheson

Regarding the Chamberlin ground lease, the Army has reviewed the documents, will move directly to Environmental Condition of the Property (ECP), and will be able to go to lease.

There was discussion on the lease and the annual payment.

Moving Properties to the Marketplace – Glenn Oder

Director Oder reported that work continues with potential developers and progress is being made on all fronts. The outcome of what has been worked on is that a new template has been created to help with other projects and position the FMA well for the future.

8. Utilities Plan Update – John Hutcheson

Mr. Hutcheson shared a presentation updating on the Mercury Boulevard Waterline project, marina redevelopment utility improvements, Ingalls Road redevelopment, and the Dominion Energy Infrastructure improvements.

Mr. Hutcheson stated that the close-out report on construction projects for the Visitor and Education Center will be provided at the June meeting.

There was discussion on recompeting major contracts.
