Question from Company 1

Question - What should the "Period of Contract" be on Page 1 of Attachment C of RFP-159-2019?
Should that be from the present to the proposed installation date? Or from the present to the end of the proposed warranty period?

Answer – February 22, 2019 to October 30, 2019.

Question from Company 2

Question - Is there a tentative budget available for this project?

Answer – The budget is not available to the RFP respondents.

Questions from Company 3

Question - Will our contract be with the FMA for both sites (FOMR and Jamestowne)?

Answer – The Contract will be with the FMA.

Question - Will the NPS be involved in the project with drawing reviews, sample approval, etc.?

Answer – The NPS and FDA will be involved in the project with drawing reviews and samples under the direction and coordination with HealyKohler Design.

Question - Will progress payments (progress towards an SOV) be acceptable?

Answer – Yes.

Question - Attachment C references "Audio/Visual Media Production Services...", is this an error?

Question - Who is the media producer?

Answer – Yet to be determined. They are scheduled to be contracted January 30, 2019

Question - Given the schedule requirement for an August 15 opening, can you furnish the following dates:

- All space fitout (construction) work complete. **Substantial Completion – 6/15/19**
- Receipt of production files for all graphics. **5/15/19**
- Receipt of final design package. **For bid, 1/22/19. Build Package, 2/22/19**
- Turnaround time for drawing and sample reviews. **5 business days**
- Receipt of final media production specs (AV equipment list). **Confirmed by media producer 3/15/19**
